## What's due?



**1 STATE form** (must be filed electronically at [www.eservices.revenue.pa.gov/NIZCRIZ/](http://www.eservices.revenue.pa.gov/NIZCRIZ/))

**AND**

**1 LOCAL form** (must be filed electronically at <https://nizfiling.allentownpa.gov/>)

**Due by January 31, 2026** for calendar year 1/1/25 to 12/31/25.

# What do I need to bring or have to complete reporting?

- 1 Copies of STATE and LOCAL NIZ forms filed in prior years.
- 2 All related entity and individual IDs for each tax type, as well as your entity FEIN or SSN.
- 3 2024 and 2025 STATE (Pennsylvania) and LOCAL tax returns and tax filings (including those made with LOCAL tax collector).
- 4 Proof of payment for all payments, including estimated payments or refunds received, made between 1/1/25 and 12/31/25 on a **CASH BASIS** (canceled checks, electronic payment records, refund check copies) for the taxes listed below:
